

### **Programme Requirements for**

Bachelor of Social Sciences with Honours in Law Enforcement and Security Management,
Bachelor of Social Sciences in Law Enforcement and Security Management and
Higher Diploma in Law Enforcement and Security Management

(Applicable to students <u>without</u> the Certificate of Law Enforcement and Security Management/ Certificate of Law Enforcement and Customs Management (CLESMCF/CLECMCF))

This 3-credit-unit system programme requirements document is applicable to students admitted in 2023 Autumn term and thereafter.

#### 1. Entry Requirement

- 1.1 To enter the Bachelor of Social Sciences with Honours in Law Enforcement and Security Management through Pathway 1 (BSSLESMH1), a student shall:
  - 1.1.1 be a Junior Police Officer, Customs Officer or above, Assistant Trade Controls Officer or above, or Assistant Officer II or above, who has successfully completed the Diploma in Law Enforcement and Security Management plus two subsequent years of working experience in the Hong Kong Police Force, the Customs and Excise Department, or the Correctional Services Department as the case may be.
- 1.2 To enter the Bachelor of Social Sciences with Honours in Law Enforcement and Security Management through Pathway 2 (BSSLESMH2), a student shall:
  - 1.2.1 be a Police Inspector or above who has passed the Standard I and II Examinations administered by the Hong Kong Police Force plus two subsequent years of working experience at inspectorate grade; or
  - 1.2.2 be an Inspector or above who has EITHER passed the Promotion Qualifying Examination for Inspectors administered by the Customs and Excise Department, OR who has three years of working experience in the Customs and Excise Department at the inspectorate grade or above after confirmation as Inspector; or
  - 1.2.3 an Officer or above who has passed the Promotion Qualifying Examination to Principal Officer AND completed the Junior Command Course, both administered by the Correctional Services Department, plus two years of working experience as Officer or above in the Correctional Services Department after the completion of the Junior Command Course.



## 2. Programme Requirement – Bachelor of Social Sciences in Law Enforcement and Security Management with Honours (BSSLESMH)

- 2.1 To be eligible for the award of Bachelor of Social Sciences in Law Enforcement and Security Management with Honours (BSSLESMH), a student shall:
  - 2.1.1 obtain 120 credit-units\* as prescribed below, of which no more than 30 credit-units shall be at 1000-level, at least 24 credit-units shall be at 3000-level and at least 24 credit-units shall be at 4000-level:
    - 2.1.1.1 24 credit-units of core courses labelled CC in Table 1;
    - 2.1.1.2 15 credit-units of 3000-level core courses labelled CC3 in Table 1;
    - 2.1.1.3 9 credit-units of 4000-level core courses labelled CC4 in Table 1;
    - 2.1.1.4 9 credit-units of 1000-level elective courses labelled EC1 from Table 1;
    - 2.1.1.5 12 credit-units of 2000-level elective courses labelled EC2C and EC2E from Table 1;
    - 2.1.1.6 18 credit-units of 3000-level elective courses labelled EC3 from Table 1;
    - 2.1.1.7 18 credit-units of 4000-level elective courses labelled EC4 from Table 1;
    - 2.1.1.8 9 credit-units of University Core courses labelled UCC in Table 1;
    - 2.1.1.9 6 credit-units of University English courses labelled UEC in Table 1;

and

- 2.1.2 attain the CGPA for graduation as prescribed in the Regulations for the award of undergraduate degrees.
- 3. Programme Requirement Bachelor of Social Sciences in Law Enforcement and Security Management with Honours through Pathway 1 (BSSLESMH1)
  - 3.1 To be eligible for the award of Bachelor of Social Sciences in Law Enforcement and Security Management with Honours through Pathway 1 (BSSLESMH1), a student shall:
    - 3.1.1 obtain 60 credit-units\* as prescribed below, of which at least 24 credit-units shall be at 3000-level and at least 24 credit-units shall be at 4000-level:
      - 3.1.1.1 6 credit-units of 3000-level core courses labelled CC3 in Table 1;
      - 3.1.1.2 6 credit-units of 4000-level core courses labelled CC4 in Table 1;
      - 3.1.1.3 3 credit-units of 2000-level elective courses labelled EC2E from Table 1;
      - 3.1.1.4 18 credit-units of 3000-level elective courses labelled EC3 from Table 1;
      - 3.1.1.5 18 credit-units of 4000-level elective courses labelled EC4 from Table 1;

<sup>\*</sup>Of the 120 credit-units required for BSSLESMH, students can complete no more than 40 credit-units of courses in a language of instruction other than English.



3.1.1.6 9 credit-units of University Core courses labelled UCC in Table 1;

\*Of the 60 credit-units required for BSSLESMH1, students can complete no more than 20 credit-units of courses in a language of instruction other than English.

and

- 3.1.2 attain the CGPA for graduation as prescribed in the Regulations for the award of undergraduate degrees.
- 4. Programme Requirement Bachelor of Social Sciences in Law Enforcement and Security Management with Honours through Pathway 2 (BSSLESMH2)
  - 4.1 To be eligible for the award of Bachelor of Social Sciences in Law Enforcement and Security Management with Honours through Pathway 2 (BSSLESMH2), a student shall:
    - 4.1.1 obtain 90 credit-units\* as prescribed below, of which at least 24 credit-units shall be at 3000-level and at least 24 credit-units shall be at 4000-level:
      - 4.1.1.1 24 credit-units of 2000-level core courses labelled CC in Table 1;
      - 4.1.1.2 15 credit-units of 3000-level core courses labelled CC3 from Table 1;
      - 4.1.1.3 9 credit-units of 4000-level core courses labelled CC4 from Table 1;
      - 4.1.1.4 3 credit-units of 2000-level elective courses labelled EC2E from Table 1;
      - 4.1.1.5 12 credit-units of 3000-level elective courses labelled EC3 from Table 1;
      - 4.1.1.6 18 credit-units of 4000-level elective courses labelled EC4 from Table 1;
      - 4.1.1.7 9 credit-units of University Core courses labelled UCC in Table 1;
      - \*Of the 90 credit-units required for BSSLESMH2, students can complete no more than 30 credit-units of courses in a language of instruction other than English.

and

- 4.1.2 attain the CGPA for graduation as prescribed in the Regulations for the award of undergraduate degrees.
- 5. Programme Requirement Bachelor of Social Sciences in Law Enforcement and Security Management (BSSLESM)
  - 5.1 To be eligible for the award of Bachelor of Social Sciences in Law Enforcement and Security Management (BSSLESM), a student shall:
    - 5.1.1 obtain 90 credit-units\* as prescribed below, of which no more than 30 credit-units shall be at 1000-level and at least 24 credit-units shall be at 3000-/4000-level:
      - 5.1.1.1 24 credit-units of core courses labelled CC in Table 1;



- 5.1.1.2 18 credit-units of 3000-/4000-level core courses labelled CC3 and CC4 from Table 1;
- 5.1.1.3 9 credit-units of 1000-level elective courses labelled EC1 in Table 1;
- 5.1.1.4 12 credit-units of 2000-level elective courses labelled EC2E and EC2C from Table 1;
- 5.1.1.5 12 credit-units of 3000/4000-level elective courses labelled EC3 and EC4 from Table 1;
- 5.1.1.6 9 credit-units of University Core courses labelled UCC in Table 1;
- 5.1.1.7 6 credit-units of University English courses labelled UEC in Table 1;
- \*Of the 90 credit-units required for BSSLESM, students can complete no more than 30 credit-units of courses in a language of instruction other than English.

and

5.1.2 attain the CGPA for graduation as prescribed in the Regulations for the award of undergraduate degrees.

#### Early Exit option for students admitted to BSSLESM or BSSLESMH

Students admitted to the BSSLESM or BSSLESMH programme may opt to exit with the award Higher Diploma in Law Enforcement and Security Management (HDLESMA). The programme requirement for the award of HDLESMA is listed in paragraph 6.

# 6. Programme Requirement – Higher Diploma in Law Enforcement and Security Management (HDLESMA)

- 6.1 To be eligible for the award of the Higher Diploma in Law Enforcement and Security Management (HDLESMA), a student shall:
  - 6.1.1 obtain 60 credit-units\* as prescribed below:
    - 6.1.1.1 18 credit-units of core courses labelled CC from Table 1;
    - 6.1.1.2 12 credit-units of 3000-/4000-level core courses labelled CC3 and CC4 from Table 1:
    - 6.1.1.3 12 credit-units of 1000-level elective courses labelled EC1 from Table 1;
    - 6.1.1.4 18 credit-units of 2000-level elective courses labelled EC2C and ECE2E from Table 1;
    - \*Of the 60 credit-units required for HDLESMA, students can complete no more than 20 credit-units of courses in a language of instruction other than English.

and

6.1.2 attain the CGPA for graduation as prescribed in the Regulations for the award of subdegrees.
